First, I verified that this method yielded at least one resident from each of the 4 housing units. Then I reviewed the race / ethnicity of the identified 13 residents. Comparing the race / ethnicity to the facility's overall percentages, I eliminated the last chosen resident who was white and replaced him with the next resident alphabetically who was Hispanic. Finally, I reviewed the list for age groups in a general way; each age group appeared to be represented.</p> <p>No residents refused to be interviewed. If one or more had refused, I would have replaced him with the next person alphabetically who was of the same race/ethnicity as the refusing resident.</p>
