Contact Visitation – Phase 1

Tentative Schedule and Subject to Change

Friends and Family wishing to schedule for Contact Visitation must register and schedule at www.icsolutions.com

- Visitation is set to reopen 09/13/21.
- Visits must be scheduled at least 24 hours prior and can be up to 2 weeks in advance.
- Visits will be cancelled if your visitor has not been approved yet, if you are in Unit 8, on disciplinary sanctions, quarantined, or a visit scheduled at the wrong time.
- Visits are 1.5 hours long. Residents may have 1 Visit per Visitor per month.
- No minors will be allowed. 2 adult visitors maximum.
- Temperature check and medical questionnaire upon entrance. If one person in the group cannot pass the entrance check the entire cohort group will be turned away. If sick, please don't come!
- Vending machines will have beverages only. No sharing of drinks.
- No games will be available to play, but we can take photos.
- Units will visit one unit at a time on a rotating schedule Monday thru Friday the first week, and Monday thru Thursday the second week. Review the attached schedule.
- You must be fully dressed in blues with ID and a mask. No shorts, sweats, thermals, necklace, or watch. You will be required to switch out to blue crocs for the visit. You will not need your medical shoes as you will be sitting the entire time.
- At this time, we are unable to accommodate special extended visits regardless of the distance travelled. This will be available again starting in phase 3.
- Any violation of the visitation rules may result in the termination of your visit and/or suspension of your visitation privileges and the privileges of your visitor.
- All Visitors must bring Identification and arrive at least 15 minutes prior to the scheduled visitation time for check in. (Only allowed items: photo ID, vaccination card, vehicle keys, coin, or debit card for vending machines).
- Out of state visitors MUST provide proof of vaccination. This will not be necessary once we hit phase 2 of reopening.
- Masks are still mandatory for both residents and visitors. No medical exceptions.

Re: Visitation Reopening

Greetings,

Tentatively/Subject to change. Visitation will be reopen Monday, 09/13/21. It will open in 3 stages with each one being less restrictive and with longer visits. Visiting will run Monday thru Friday with 3 sessions per day on a rotating schedule by unit. The visit sessions will be

- 0830-1000 Check in: 0815
- 1100-1230 Check in: 1045
- 1330-1500 Check in: 1315

Phase 1 is the most restrictive and will run a minimum 14 days.

- 1.5-hour visits
- No minors
- No extended visits.
- If both the resident and the visitor provide proof of vaccination then they will enjoy visitation much as they have before including hugs, holding hands, etc. If either the visitor or the resident is NOT vaccinated, then it will be a strictly no-contact visit with a plexiglass divider.
- At this point **masks are still required** in the facility by both residents and visitors. No medical exceptions. Hopefully that will change by the time we get to Phase 2 of reopening, but only time will tell.
- Both resident and visitor(s) will be required to show proof of vaccination upon each arrival to be seated at one of the less restrictive tables. It must be presented at each visit.
- Vending machines will be limited to beverages only. No sharing. Each person must have their own drink
- If the visitor is from out of state, then they **MUST** provide proof of vaccination to visit in phase 1.
- If your visitor has been approved in the past but just needs to renew, they will be allowed to visit and will fill out a renewal application upon arrival.
- All visitors will be screened and have their temperature taken upon entry. If anyone in the group does not pass the screening the entire group will be turned away to avoid another potential Covid-19 outbreak in the facility.
