#### What is a Registered Apprenticeship?

Registered Apprenticeship is a highly flexible training and workforce development model that combines on-the-job learning, related instruction and paid work experience. Apprenticeship will prepare and train our work force to meet industry demands and deliver on the promise to hire Idahoans first!

The construction industry is just one example of industries that offer apprenticeships. Apprenticeships are also available in advanced manufacturing, automotive industries, healthcare, information technology and geospatial technology. Unlike a four-year degree program at a university where you pay, apprenticeships pay you while you train for well-paying jobs with promising futures.

#### **Interesting Facts about Registered Apprenticeships:**

- Is one of the oldest and most portable industry credentials, which makes you eligible to work anywhere you can land a job for which you qualify
- Offers wage progression on an increasing scale
- Provides on-the-job learning industry driven skills that make you more competitive in the labor market

**IDOC Community Mentorship Program** 

Mentors are community volunteers from around the state who will help you:

- ▶ Set and meet goals
- ▶ Problem-solve and make good decisions
- ▶ Introduce you to other supports and people
- ▶ Find a job or further your education
- ▶ Teach you skills
- ▶ Introduce you to pro-social networks and activities.

#### The Process is Pretty Simple...

- ▶ Complete a Request for Mentor and submit to facility VRC or case manager about 30-90 days before your release.
- ▶ Once a mentor is assigned you should get an e-mail from the Program Manager (if you have e-mail) about who your mentor is. If you don't have e-mail, the VRC will let you know.
- ▶ You will then be provided with an <u>initial</u> phone call to your mentor from a staff phone to start the conversation about what you will need upon release.
- ▶ Communication can continue via phone, e-mail, or letter. If you are housed in a CRC, mentors may visit with approval from facility head.
- ▶ Upon release, you will continue to meet with your mentor and, together with your PO, develop a plan and work towards a successful transition.
- ▶ If you are released without having a mentor, you can still get a mentor while on supervision. Discuss it with your PO or request one through the IDOC website.
