\_\_\_\_\_ (herein, 'parolee') hereby agrees as follows:

On \_\_\_\_\_, parolee was released on parole;

On \_\_\_\_\_, parolee was arrested on parole violation charges;

Parolee has had **or** has waived a preliminary hearing on the parole violation charges; and

Parolee has been assessed **and** approved for substance abuse treatment at the Correctional Alternative Placement Program (CAPP) facility.

**Based on the foregoing, parolee hereby requests a continuance of parolee's fact-finding violation hearing so parolee can be placed in the CAPP facility for substance abuse treatment.**

**Parolee further understands and agrees as follows:**

The Parole Commission Warrant that will be (or has been) issued for parolee will remain active while parolee is in CAPP placement **and** until parolee is either released back to parole **or** has a violation hearing. While the Parole Commission Warrant is active, parolee's parole is suspended **and** parolee is required to remain in custody. Parolee's time in the CAPP shall be credited to time served.

Parolee's participation in the CAPP may be terminated at any time at the discretion of parolee's supervising officer **and** CAPP staff.

If parolee successfully completes the CAPP, parolee's pending violation charges which have not resulted in a new, separate criminal charge, will be dismissed **and** parolee will be placed back on parole without further hearings, **and** the Parole Commission Warrant shall be extinguished. If after completing the CAPP, parolee commits a violation of parole, any parole violations committed prior to CAPP placement can be used and brought before the Idaho Commission of Pardons and Parole.

If parolee fails to successfully complete the CAPP, parolee shall remain in custody for the violations on which parolee was initially detained. Parolee will be entitled to a fact-finding violation hearing **and** revocation hearing on those charges. Parolee's parole may be revoked **or** reinstated, **and** if revoked, parolee's time on parole prior to CAPP placement shall be subject to forfeiture in whole **or** in part, at the discretion of the Idaho Commission of Pardons and Parole.

If no CAPP bed space is available **and/or** if after screening for admission to the CAPP an extended time exists to enter the CAPP, parolee will be informed of alternatives to be decided by parolee's supervising parole officer (at that officer's discretion). These alternatives may include, but are not limited to, alternate intermediate sanctions **or** being placed on a waiting list for CAPP placement.

The Idaho Commission of Pardons and Parole **and/or** the Idaho Department of Correction (IDOC) have sole discretion to determine parolee's placement in, **or** removal from, the CAPP. By signing this form, parolee understands **and** agrees that he has no right to be placed in the CAPP **and** understands that he has no right to remain in the CAPP if placed in the facility.
